Jim made a motion to accept the minutes; Lisa seconded; the Board voted unanimously in favor.

Jim reported for Frank that there were 13 calls for April. Pump testing on all trucks will be May 29.

Jim stated that the Memorial Day parade will begin at 11:30 on May 26th.

Jim reported that fire department has been doing Spire inspections. Frank reported to Jim that their sprinkler systems need to be up to code.

Larry reported that 3 ballyards were stolen from the trail. One was found. A report was made with the Sheriff's Department.

Lisa made a motion to pay bills checks 14641 thru 14677 in the amount of \$60,902.50; Jim seconded; the Board voted unanimously in favor.

Jim reported that NAD had 24 calls for April for Harpersfield with a response time of 5.1 minutes. There were 115 total this time last year and 113 so far this year.

I okay-ed them tagging Harpersfield in their post regarding these events. I will have a sit-down meeting with her next week on ways in which we can continue to collaborate. 3. Resident on South County Line Road would like to add another driveway to his property. The weight limit sign for the county line bridge is obstructing his path. Can that be moved? Do we happen to have a "Slow Children at Play" sign that could be put up on that road?

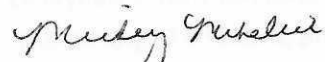

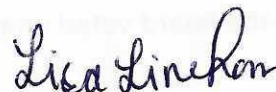
Jim made a motion to adjourn; Lisa seconded; the Board voted unanimously in favor.
