- (1) All fees shall be paid at the time of application submittal. Fees are not refundable after legal notices sent and posted. Continuances, at the request of the applicant or as a result of insufficient documentation provided by the applicant, shall require a new fee, as outlined above.
- (2) Final zoning permit fees still apply, subsequent to board approval, as applicable and outlined above.
